The Role of National BIOEAST HUBs in the BIOEAST Region





- The Mission of the BIOEAST Initiative development of knowledge & cooperation based circular bio economies to enhance inclusive growth in the BIOEAST region
- The BIOEAST Initiative is a political initiative and as such only the ministerial bodies can become members
- Along with the development of the BIOEAST Initiative, thematic working groups, a great variety of private organisations from the research as well as business sectors have expressed support and interest to participate
- The BIOEAST Governance and Roadmap defines the national HUBs as a national network to gather and mobilise stakeholders

2012 - European Strategy for the Bio Economy

2016 - establishment of the BIOEAST initiative

2017 - revision of the European Bioeconomy Strategy

2018 - establishment of an Interministerial group in CZ

2019 October - kickoff meeting of the BIOEASTsUP project

2019 November - European Green Agreement

2019 November - establishment of BIOEAST HUB CZ with the support of the Ministry of Agriculture of the Czech Republic and in accordance with the Governance Paper of the BIOEAST Initiative by the Agriculture Research, Ltd (Zemědělský výzkum, Troubsko, s.r.o - ZVT)

2020 February - kickoff meeting of the BIOEAST TWG Fresh Water based Bioeconomy Initiated by the Ministry of Agriculture CZ

2020 April - on line meeting of the interministerial group and BIOEAST HUB CZ members

2020 December - on line meeting of the interministerial group and BIOEAST HUB CZ members
